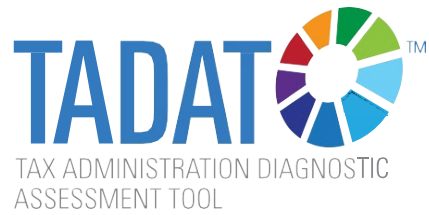

The results of a TADAT assessment provide the tax administration, capacity development partners and other stakeholders—with a baseline of the tax administration system's health status from which reforms and related support can be planned and implemented.
