11h15 – 13h00 SESSION 1: IMPLEMENTATION OF TAX ADMINISTRATION ICT SYSTEMS: COUNTRY EXPERIENCES

In this session, countries will present on the processes they have gone through to implement ICT systems in tax administrations. This will involve a discussion on the enabling laws and policies to set up the new systems, the political environment (political will and support or interference), the champions of the implementation, the transition process from the old manual system to the new system. It will explore the processes of eliciting system requirements from all stakeholders and the data requirements that the tax administration focused on. The session will also probe how the tax administration developed the system to meet the specified requirements, the re-engineering journey, the nature of applications that they deployed and the issues regarding people (human capacity), both internally and externally. It will also be important to bring out the key performance indicators for the systems. The presenters of the session will guide the discussion and engage the audience in an informative discourse. The discussion outcomes will feed into the development of a guideline document on implementing ICT tax administration systems in Africa i.e. *Requirements elicitation, Data Requirements, Applications and People Issues*.

The session will shed light on the cost of acquiring, supporting and maintaining ICT systems in tax administration in Africa including customs, domestic taxes, and resource management functions to highlight the key cost centres which should be given attention in the proposed ICT framework for tax administration systems. The key discussions should explicitly highlight the Infrastructure set up, the approach to developing applications, the supportive human resources that augment the use of ICT systems and the evaluation of cost and benefit from the systems. The presenters should back up their presentations with the cost of ICT in Software (applications) acquisition, Software Maintenance (Change requests), Hardware acquisition, Hardware Maintenance, Licenses cost (Oracle, Microsoft, Linux), Network Infrastructure Links and Total ICT recurring Budget per year (lump sum).

11h30 – 13h00 SESSION 5: TAKING IT FORWARD: HOW TO GET IT RIGHT?

During this session, delegates will group in separate teams to discuss components for the approaches and proposals leading to an acceptable framework/checklist for implementing ICT systems in Africa. The followings drivers will be considered including soft-issues and technical issues: 1) political will, 2) policy and legislative support, 3) Champions of the implementation, 4) mobilization of various stakeholders' commitment, 5) elicitation of requirements, feasibility, functional versus non-functional requirements, 6) acquisition (internal versus donor support; in-house versus commercial off-the-shelf products); 7) implementation of the enterprise architecture (matching business processes with technology), 7) long-term overall sustainability, etc.

The group leaders will draw lessons from previous sessions, country experiences, and good practices to draw outcome statements and areas that need further investigation for tax administrations. The chair will conduct a wrap up of suggestions from the teams

SESSION 6: A MODEL AFRICAN TAX ADMINISTRATION ICT SYSTEM: WHAT SHOULD IT LOOK LIKE?

African tax administrations have historically deployed outsourced systems in their functions. The result has been the haphazard deployment of multisource applications, infrastructure and hardware, often incompatible, with staff not skilled enough to operate them. This has undermined their value to the institutions and constrained the return on investment. In this session, the presenters will guide the audience towards a uniform but adaptable tax administration system for African countries. The discussion will also create insights towards what should form an African tax ICT systems field guide, i.e. the check list or keys steps to follow when implementing a tax ICT system. The session should also pick from the lessons and experiences of the previous discussions. In addition, the session should highlight the key synergies that African countries should harness from working on a uniform tax administration standard infrastructure with the possibility for each country to assimilate it to its unique ecosystem.

This session should also evaluate whether African countries are ready to develop local ICT solutions like mobile apps and systems to address the DRM challenges of the day (should the ICT systems be outsourced or built-in-house?). The session will answer these key questions by exploring the potential pros and cons of either alternative.
